## ISCC's three main certification schemes to support compliance with legal and voluntary sustainability requirements



ISCC EU

- Sustainable fuels for transport, electricity, heating and cooling in the EU under the RED
- To demonstrate compliance with the EU's sustainability and GHG criteria for biofuels, bioliquids and biomass fuels and now also for RFNBOs, RCFs



## **ISCC PLUS**

- Circular and biobased chemicals, plastics, packaging, textiles, ...
- Sustainable fuels outside the EU
- Sustainable food and feed
- Renewable feedstock from using renewable energy sources
- ISCC Carbon Footprint Certification (ISCC CFC) developed




### **ISCC CORSIA**

- Sustainable aviation fuels under ICAO CORSIA
- To demonstrate compliance with the sustainability and GHG criteria for CORSIA eligible fuels

ISCC also operates **ISCC Japan FIT** for the production of renewable electricity in Japan. Eligible raw materials include palm oil, palm kernel shells, and other kinds of shells





### Under ISCC PLUS, mechanical recycling operations are covered












Overview of some ongoing developments of plastic regulations worldwide




EU	Packaging and Packaging Waste Regulation (PPWR) Single use plastic directive (SUPD)
UK	Plastic tax since 2022. <b>ISCC joined a number of roundtable</b> discussions $\rightarrow$ Consultation result available
SPAIN	Plastic tax since 2023. ISCC under accreditation process
ITALY	Plastic tax start postponed
KOREA	ISCC PLUS is recognized under the Post-consumer Plastic Recycled Content Labelling Policy
JAPAN	Japan's policy for bioplastics towards 2030 and 2050
USA	FTC Green Guides, EPA National Recycling Strategy, EPA (draft) Plastics Pollution Prevention, California Plastic Pollution Prevention and Packaging Producer Responsibility Act Regulations Division of Circular Economy
AUSTRALIA	National framework for recycled content traceability. ISCC submitted self-assessment tool
CANADA	Recycled content and labelling rules for plastics regulatory framework



# The Trilogue Meeting for the Green Claims Directive is planned for Q4 2024



The Green Claims Directive aims to regulate and standardize environmental claims made by companies to prevent "greenwashing" and ensure transparency for consumers.

EUROPEAN COMMISSION

#### **Actions by ISCC:**

- Stakeholder Engagement (e.g. ISCC working group meetings with brand owners, joining an ISEAL task force)
- Market Monitoring (reviews market trends and aims for compliance with GCD)
- Discussions with EC
