



# Therefore, regulations on the use of green claims are becoming more important

- Creating trust for consumers
- Helping the consumer to make more responsible purchasing decisions
- Fighting against greenwashing and speaking one language
- Improving legal certainty of green claims
- Helping to accelerate the transition to a bioeconomy and circular economy



# General requirements for the use of ISCC logos and claims

- Claims must be clear and easy to understand
- Reference to the certified part of the product
- Correct wording for when mass balance is applied (e.g. supporting, sourcing recycled material)
- The raw material category should be mentioned
- The certified percentage must be included
- →ISCC claims need to be **approved by ISCC**
- → Guidance document "ISCC 208 Logos and Claims"

## **Examples of off-product communication via CSR** reports, press releases and websites



In 2022, the Ferrero Cork plant achieved ISCC PLUS certification<sup>15</sup> to pilot the mass-balance approach for recycled plastic from chemical recycling.

Our first pilot in chemically recycled plastic from mass-balance adoption in plastic packaging is with the Tic Tac brand. Tic Tac is using 50% recycled plastic (based on mass balance) for the Tic Tac 200-pill box in our Cork plant.


### WHAT IS ISCC?

International Sustainability & Carbon Certification (ISCC) is a globally applicable sustainability certification system and covers all sustainable feedstocks.

From feedstock conversion into biobased plastic, to brush head manufacturing and finally packaging, to ensure that biobased mass balance certified material is properly utilized across Oral-B Brush Heads.

# KitKat introduces ISCC certified wrappers linked to 90% recycled plastic (mass balance approach)

#### **ISCC Certified**

Our Kitkat wrappers with 90% recycled plastic are ISCC certified. The recycled material is allocated using the ISCC mass balance approach. ISCC is International Sustainability & Carbon Certification: it is a system that supports new recycling technologies that transform hard to recycle materials into new plastic, working towards a circular economy.

This means our Kitkat wrappers are made using a mix of virgin and recycled plastics. Each wrapper may vary in the total amount of recycled plastic it contains - some may contain more some may contain less. The process is certified by ISCC to ensure that a minimum of 90% recycled material is allocated to the entire batch of KitKat wrappers (mass balance approach).



### The ISCC licensing scheme for brand owners



- The supplier
  - holds a valid ISCC certificate
  - issues ISCC Sustainability Declarations for the ISCC certified material



- The licensee
  - receives an ISCC certified final product
  - cannot fundamentally alter it



- The licensee
  - is a brand owner under whose brand name the finished good goes into the market
  - is allowed to communicate



### Applicable licensing setup - example



The **brand owner** would like to make claims about ISCC certified materials. They **receive a certified finished good/packaging** with the ISCC on-product logo and/or on-product claim.
