PLEASE NOTE:

The next **ISCC and PLUS Basic Training** in North America will take place in Las Vegas on **November 20 – 22, 2019**. The Training will cover all topics relevant for ISCC certification. This includes:

- Implementation and verification of **deforestation-free supply chains**. The first day of the training will be focussing on the framework **requirements for the different markets** (biofuels, food, feed, bio-based products) and provide an overview of the ISCC certification processes and related documents. Another focus point is the **conduction of sustainability audits** on farm/ plantation level and the assessment of **no go areas and land use change**.
- Requirements for **traceability and mass balance**. Day 2 will focus on the role of the supply chain elements that must be covered by certification and the ISCC requirements for traceability and chain of custody.
- **Greenhouse Gas (GHG) requirements, calculations and verifications** will be the topic of Day 3.

Extensive **group work sessions** will round up all three training days.

The training will be held in English. The **participation fee** is 1.100 €. An early bird discount of 10% is offered for registrations submitted at least 14 days prior to the training.

The participation in the ISCC EU and PLUS Basic Training is a mandatory requirement for all auditors before they can conduct audits under ISCC.
